LEGISLATIVE REPORT

S1470 - (Lagana) Provides workers' compensation benefits for certain public safety workers who developed illness or injury as result of responding to September 11, 2001 terrorist attacks.

This bill provides that a public safety worker who participated in the response to the September 11, 2001 attacks and is treated or monitored through the World Trade Center Health Program established by the Centers for Disease Control is presumed to be compensable under the State workers' compensation law without respect to when the worker files his claim for compensation, except that the claim is required to be filed within two years after the effective date of the bill. A worker is deemed ineligible for the benefits if the worker is eligible for benefits for the same injury, illness, or death under workers' compensation programs of other states or the federal government.

The bill requires the Division of Archives and Records Management in the Department of State, and each county, municipality, regional or joint public safety entity, or other agency involved in the public safety, to notify all active and retired personnel and next-of-kin, if the personnel are deceased, of the presumption of compensability within three months of the effective date of the bill.

LITIGATION REPORT

NJ Supreme Court Rules Commute Compensable Where Employee Operating Authorized Vehicle and In the Course of Employment

Henry Keim v. Above All Termite and Pest Control (A-30-22) (087603), decided on November 21, 2023 reversed the decision of the NJ Workers' Compensation Judge dismissing the claim with prejudice pursuant to the going and coming rule. The NJ Appellate Division reversed the Trial Judge's ruling, and the NJ Supreme Court unfortunately affirmed. Henry Keim was a salaried pest control technician, and his employer provided him with a work vehicle. Keim kept this work vehicle at his residence, and on workdays drove the vehicle from his residence to various jobsites and then returned home to his residence with the vehicle. The employer's policies limited the amount of work supplies left in the vehicle overnight, and technicians were authorized to use their own discretion and if necessary drive to the employer's location to reload their supplies and then drive to their jobsites. On the morning in question, Keim logged in, received his daily schedule and realized he needed supplies. He drove to his employer's shop directly to reload his supplies and was involved in a motor vehicle accident sustaining injuries.

The NJ Supreme Court noted the Trial Judge found Keim was commuting to work, and further reasoned Keim's arguments of the authorized vehicle rule were irrelevant. The NJ Appellate Division and Supreme Court disagreed with the Trial Judge's analysis. The NJ Supreme Court reviewed NJSA 34:15-36 finding four exceptions to the going and coming

rule including the "premises rule"; "special mission rule"; "paid travel time rule"; and "authorized vehicle rule". In order to arrive at their conclusion, the Supreme Court examined the meaning of operating an "employer authorized vehicle" while performing "business authorized by the employer". The decision found an accident is compensable where "(1) the employer authorizes a vehicle for operation by the employee, and (2) the employee's operation of that identified vehicle is for business expressly authorized by the employer."

This decision is troubling for NJ employers and insurance carriers. The decision clarifies and limits the going and coming rule, and essentially creates more compensable accidents pursuant to Section 36 and the four (4) exceptions to the going and coming rule.

With recent increases to fees for medical experts, additional presumptions for EMTs and paramedics for strokes and heart attacks, and pending legislation relative to increasing the percentage of counsel fees, NJ is becoming a scary and expensive place to litigate Workers' Compensation claims. NJSIA continues to monitor both litigation decisions and proposed legislation and where/when appropriate take action on behalf of NJ employers. However, with the recent changes noted above, we urge your companies, as NJ employers to get involved and organize strong opposition to some of the decisions that adversely affect employers. We seek a fair and equitable workers' compensation system; these decisions, and pending legislation favor employees, not equity.
